## Message from the President

A Portrait of the Art as a Portrait of the Artist: Some Musings on the 2012 Member Show

In my native language, Portuguese, the word for exhibition also means exposure, and I find that very fitting to explain how a lot of artists feel about exhibiting their work. There is always excitement at having your artwork hanging at a gallery, but also some degree of apprehension. The work may invite criticism, it may invite comparison, or it may invite a look at our intimate self. Either way, most of us are a bit self-conscious about our art, as if the viewer of the painting were instead staring at us wearing nothing but our most revealing swimwear. (Sometimes it gets worse: If your work is on the same wall as that of much more well-known professionals, then you feel like you are standing in your underwear in a line-up of top models.) Now joking aside, I have noticed some of this mix of pride and self-consciousness in many of the top artists I have met or studied with, and


saw it again in some of the artists I spoke to during the Member Show opening reception. Does this apply to a group as well as to the individuals?

In art philosophy class, I learned that a painting, regardless of its subject matter, is always a portrait of the artist. If this is so, then by extension the Member Show is the truest portrait of the CWS as an artist organization. Visiting the exhibit during the opening reception, I marveled at what a diverse group we are: Such variety of subject matter, approaches and interests. and skills! The artwork is of high quality, but is not pretentious, and it is both familiar and new. Viewing the paintings by so many people I know is like reading postcards sent by them from distant real and imaginary shores; they are

telling me where they have been. At times the messages were surprising: Bold paintings by very subtle people, and delicate paintings by very strong personalities. I notice a

vague mapping of the instructors we have had in our workshops: Their influences are clearly traceable in the exhibit. I am tempted to analyze further... The multiple pieces by a member might indicate they have been very productive and consistent in their work; could it be that the absence of someone's work may betray the fact they have been too busy to submit at this time?

I wonder if other visitors will see only individual paintings, or will, like me, also imagine them as the collective mosaic of the association we represent. This is the self-consciousness speaking... but then I look around me at the paintings again, at how well the show has been organized by Jan Stewart and Karen Heber, and conclude we have plenty be proud of, no need to be shy at all. Congratulations to the many members exhibiting and to the award winners chosen by juror Molly Davis! I hope to see even more members enter and be shown next year.
